A letter from Riverbend Leadership...

Dear Riverbend supporters,

Less than a year into our tenures as Riverbend's new Board Chair and Executive Director, we want to take this chance to say **THANK YOU**. Your unflagging support over these past two pandemic years saw Riverbend through a perilous time and onto solid ground again. Because of you, we are proudly carrying out Riverbend's commitment to equitably connecting young students to the healing effects of time spent in nature.

2021 was a year of change in which Riverbend bid a fond farewell to Executive Director Laurie Bachman, who transformed the organization over 15 years. The outgoing Board Chair, Dave Copas, spearheaded the effort to successfully transition leadership while maintaining operational stability. While connecting children to nature on Riverbend's idyllic Gladwyne preserve has been our mission for 47 years, under Laurie's leadership Riverbend also expanded programming offsite to become a regional environmental education powerhouse, providing elementary and middle school teachers in hundreds of elementary schools with the latest skills and tools they need to foster students' interest in STEM and improve academic outcomes.

For a decade, Riverbend has been fiercely dedicated to children living in neighborhoods with nature deficits. During the pandemic, we pivoted to deliver our inquiry-based nature education outside on school yards, on Zoom, and via video. Our environmental educators are thrilled to once again be teaching children in-person in their schools and at our Gladwyne preserve.

Because this is a critical decade for the future of our children and our planet, Riverbend now is harnessing environmental education as a platform for civic action on behalf of the natural world via our Nature Based STEM Community of Practice program. In Kensington's Elkin Elementary classrooms, Riverbend is supporting third graders in exploring indicators of ecological health on their own school grounds and to present solutions to school leaders. In Northwest Philadelphia, students will venture out to observe the flow of water on their schoolyard, consider watershed impacts, and present a plan to the local water department. These educational programs for students -- the majority of whom are low-income -- are 100% funded by dedicated donors and partners like you.

2022 will mark the return of a full schedule of public events at Riverbend's Gladwyne preserve, like "Earth Day Tree Planting" and "Tadpole Transformations." Recognizing the challenge of parenting in the era of climate change, these events offer families a fun chance to bond in nature and provide parents with tools for teaching kids to be aware of their impact on the environment. Riverbend hopes to empower families to proudly embrace the important role they can play as advocates for the natural world.

Your charitable gifts in 2020 and 2021 made these Riverbend programs possible for thousands of children. And with your help we can reach many thousands more this year. Together with our partners and donors—and with equitable access as our guiding light—we have educated and will continue to educate the environmentalists of the future across the greater Philadelphia region.

Education Programming Update

Evolving Riverbend's Education Outreach

Riverbend and Partners Help Pass Stronger Science Standards

Last summer, Pennsylvania was poised to adopt new standards in the state-wide science education curriculum. Here at Riverbend, we welcomed the much-needed update to science standards that were 19 years old and outdated. The newly proposed standards featured greater integration between science and technology and an emphasis on deep content knowledge, however environmental concepts like watersheds were eliminated. Academic standards are the framework that ensure students graduate with specific skills and knowledge and therefore it is critical that they explicitly include environmental concepts like watersheds, ecology, agriculture, and climate change. Environmental education in schools builds content knowledge through authentic investigation, hands-on learning, and field trips to ensure that students explore and understand the world around them, beyond their classroom walls.

Riverbend joined thousands of educators, concerned citizens, and elected leaders to participate in the public comment period regarding these standards. Riverbend pulled together our partners, including parents, board members, elected officials, and local school board members to sign a letter submitted through public comment. In January, the Pennsylvania State Board of Education voted to approve the standards with the addition of an environmental literacy domain. We are hopeful that this will pass through the legislative process to final approval and implementation in schools in the next few years. This change will ensure that all students in Pennsylvania build environmental literacy in their classrooms and graduate prepared to thrive in the face of complex and changing environmental conditions.

The pandemic brought unprecedented change to Riverbend's schools, children, and families, hitting hardest for students of color and those attending schools in low income zip codes. As schools and families struggle to build a new vision for the future, we believe connecting with nature will be an integral part of the path forward.

Riverbend has created the Nature Based STEM Community of Practice to bring together Riverbend's strengths in education and expertise in sustainability to engage students in environmental education that is authentic, meaningful, and nature connected.

The Community of Practice prepares schools and environmental education centers to transform classrooms, using local environmental issues as a platform for project-based, equitable education experiences. We launched the program in August 2021, with teachers and environmental educators from Philadelphia, Upper Darby, and Montgomery County. Teachers spent three days in an intensive summer institute focused on nature-based learning and equitable instruction. Since September, 17 teachers have convened monthly and this spring, Riverbend environmental educators will reach their 525 students through visits to their classrooms and a watershed education experience at their school.

A second program, Riverbend's Nature Based STEM Series program, directly reaches students through multiple visits to classrooms, environmental education resources, video content, and outdoor field experiences in school yards. Classroom visits are implemented in person, virtually or through pre-recorded video when necessitated by pandemic surges. Outdoor field experiences are designed to engage students in local environmental exploration and problem solving at their school. Students receive much needed outdoor time connected to their curriculum.

The pandemic shined a light on the importance of connecting with nature and shifting to a more sustainable world. Our vision is that children will build environmental literacy and resilience, and grow up better prepared to face complex environmental issues and solve the world's greatest challenge ahead.

Aquaponics is Back!

We are happy to report that Riverbend's Aquaponics greenhouse is back up and running. During the beginning of the pandemic, Riverbend shut down the greenhouse to reduce costs and save energy. Now, through a generous grant from Constellation as part of their *Energy to Educate* program, we are returning the greenhouse to a fully-operational state. The grant was co-authored by Riverbend and Cupola Academy as it benefits young learners from both organizations.

As of this writing, we are restoring the greenhouse with a "Grand Re-opening" planned for spring. In addition to restoring the greenhouse to full operation, we are upgrading the experience for visitors through the addition of interpretive graphics and for students through an app based self-guided field trip.

Riverbend, TreeVitalize, and Young Volunteers

Since 2008, Riverbend has been working with volunteers to plant over four thousand trees, remove destructive invasive vines, and improve the habitat at our preserve for wildlife, students, and the health of our stream. We have been fortunate to have been supported in this work by the TreeVitalize Grant program, managed by the Pennsylvania Horticultural Society, with funding from the Pennsylvania Department of Environmental Protection's Growing Greener program, PECO, and Aqua PA for projects located within its source water protection zones.

Throughout 2021, young people from our community and nearby schools and universities came to Riverbend and gave over 700 hours of volunteer time. *For our TreeVitalize project, these young volunteers planted 226 trees, and 93 shrubs, as well as native perennials and seeds, restoring an area of woodland that is losing canopy due to death of many ash trees caused by the Emerald Ash Borer as well as the impacts of invasive vines.*

During the summer, we welcomed teen volunteers once a week who kept our trails clear, cleaned up after storms, and worked together with our summer Habitat Interns to pull invasive vines and plant a pollinator garden.

After more than a year of living through the pandemic when our programs were largely shut down, it was wonderful to welcome so many young people and work together safely outside on such impactful projects. **We thank all of our young volunteers who gave their time and hard work to help sustain and care for Riverbend during the past year. Summer Camp 2021

A look back at this past Summer Camp season at Riverbend



Riverbend is cherished in the hearts of children and families on the Main Line. Summer camp has been integral to the healthy growth and development of children for 40 years. Canceling camp in March of 2020 was a low point, but we have since reached hundreds of camp families successfully and without COVID transmission for two seasons.

For this upcoming summer, we have added a new Counselor in Training (CIT) program for children ages 11-13 years. This leadership experience introduces campers to experts in environmental issues, service learning and career exploration—all while spending their days fully outdoors, immersed in nature. CITs visit regional environmental centers for weekly field trips and work directly alongside counselors, developing experience working with younger children.



Farmhouse Renovation Complete!

In 2021, Riverbend successfully completed the renovation of the historic farmhouse on the preserve property. The goal of the project was to add additional space for education programs and provide a critically needed home for an onsite caretaker. Having a caretaker live onsite will improve the safety and accessibility for all who visit Riverbend for education and recreation. The farmhouse was neglected for many years, and had fallen into a state of significant disrepair. The renovation of this historic structure included the demolition of the interior walls, reframing, new electrical and plumbing for two bathrooms and a kitchen, a new HVAC system and additional insulation and deep cleaning. We are excited about this worthy and necessary investment in Riverbend’s future.

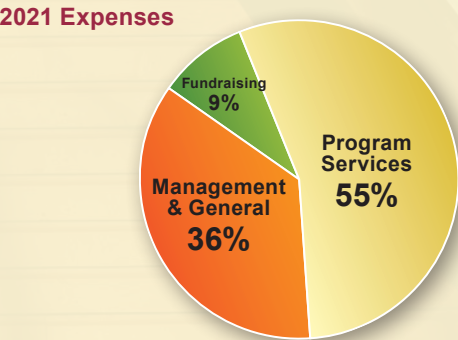
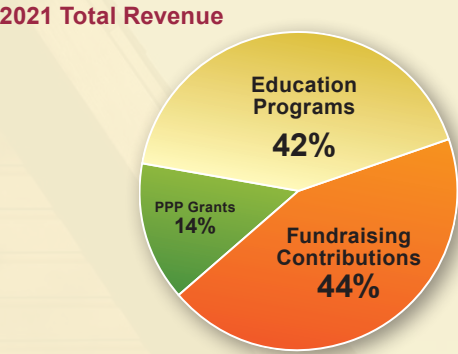

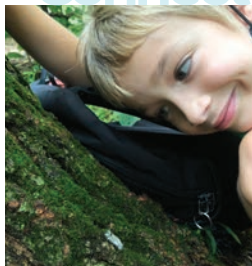
